- 7.) **Knows how to swim** (only in the case of activities that take place in an aquatic environment).
- 8.) That the activity and the risks involved has been explained to you, as well as the conduct you should adapt.
- 9.) You are not under the influence of **alcohol, drugs or medications** that could endanger yourself others around you.
